Carroll ISD Gifted Program Provisional Placement Form

Provisional placement is an opportunity for new Carroll ISD students who have been identified in an equivalent gifted program to participate provisionally in Carroll ISD gifted program.

Students eligible for provisional placement are...

- Students identified as gifted in a previous school district or
- Students who achieved a gifted program qualifying score on Carroll ISD abilities and achievement tests during the previous year but did not enter the program.

PLEASE NOTE:

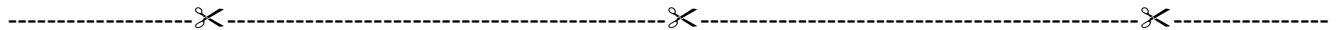
1. Students who enter Carroll Independent School District from other districts within the school year may be referred for Provisional Placement in the gifted program immediately following their enrollment.
2. It will be the responsibility of the parent(s) to provide any current data that is required for provisional consideration. **Provisional placement will not be granted in the absence of official records.**
3. Students transferring into the district who were previously identified as gifted in another district and who have records of comparable testing (TEA section 39.032) may be eligible for provisional placement in the gifted program until the next regularly-scheduled testing occurs. The decision for provisional placement will be based upon the student's transferred records. As per board policy, this decision should be made within 30 days of the request for provisional placement.
4. The District Gifted Program Screening committee will base its decision on the comparability of the records with the qualifying standards for the Carroll ISD gifted program. If provisional placement is granted, the placement is provisional until the student's completion of the next testing cycle.
5. Parents must approve the provisional placement in the gifted program. The student will be assessed during the next testing period and must meet district criteria for permanent placement in the Carroll ISD gifted program.
6. Provisionally placed students not meeting district criteria are ineligible for permanent placement in the gifted program during that calendar year and will not be allowed to participate in the gifted program after it is determined they are ineligible.
7. Former provisionally placed students who did not meet the district criteria for placement in the gifted program may be re-screened upon parent request. This request must be made within the designated dates of the annual referral period for current CISD students.

REQUIREMENTS FOR PROVISIONAL PLACEMENT:

- Completion and return of this agreement
- Prior assessment information to include ability and achievement test scores
- Student identification data from previous district
- Gifted teacher evaluation from previous district

LENGTH OF PROVISIONAL PLACEMENT:

The period of provisional placement will terminate with completion of Carroll ISD gifted program screening. At that time, provisional students will either be permanently placed or immediately exited from the gifted program depending on the outcome of Carroll ISD gifted program screening.
